# SARAWAK AGRO VENTURE CAPITAL FUND

A financial facility dedicated for financing viable agro-based economic activities, which is managed by SLDB. As one of the enablers to accelerate the effort to declare Sarawak as a net food product exporter by 2030.



# BUSINESS START-UP GRANT (BSUG)

## *Purpose*

1. To pay capital and development cost
2. Purchase of equipment
3. Working capital (purchase raw material, input, part of salaries & administration expenses)

## *Grant Limit*

Maximum of RM500,000.00

## *Eligible Applicant*

Sole proprietor; partnership; private limited company

## *Criteria*

1. Had commenced activity & activity is on going
2. Possessed basic equipment & infrastructure
3. Had acquired the project site/land/building (own ownership/rental)
4. Had established some marketing/sales network/outlets
5. Had started selling

# BUSINESS GROWTH & EXPANSION FUND (BGEF)

## *Purpose*

To promote & accelerate the development of: commercial production; processing & marketing of agro based products and services by providing fund for new development or expansion of present capacities.

## *Grant Limit*

Maximum of RM 7.0 million or 70% of estimated Total Project Cost, which ever is lower

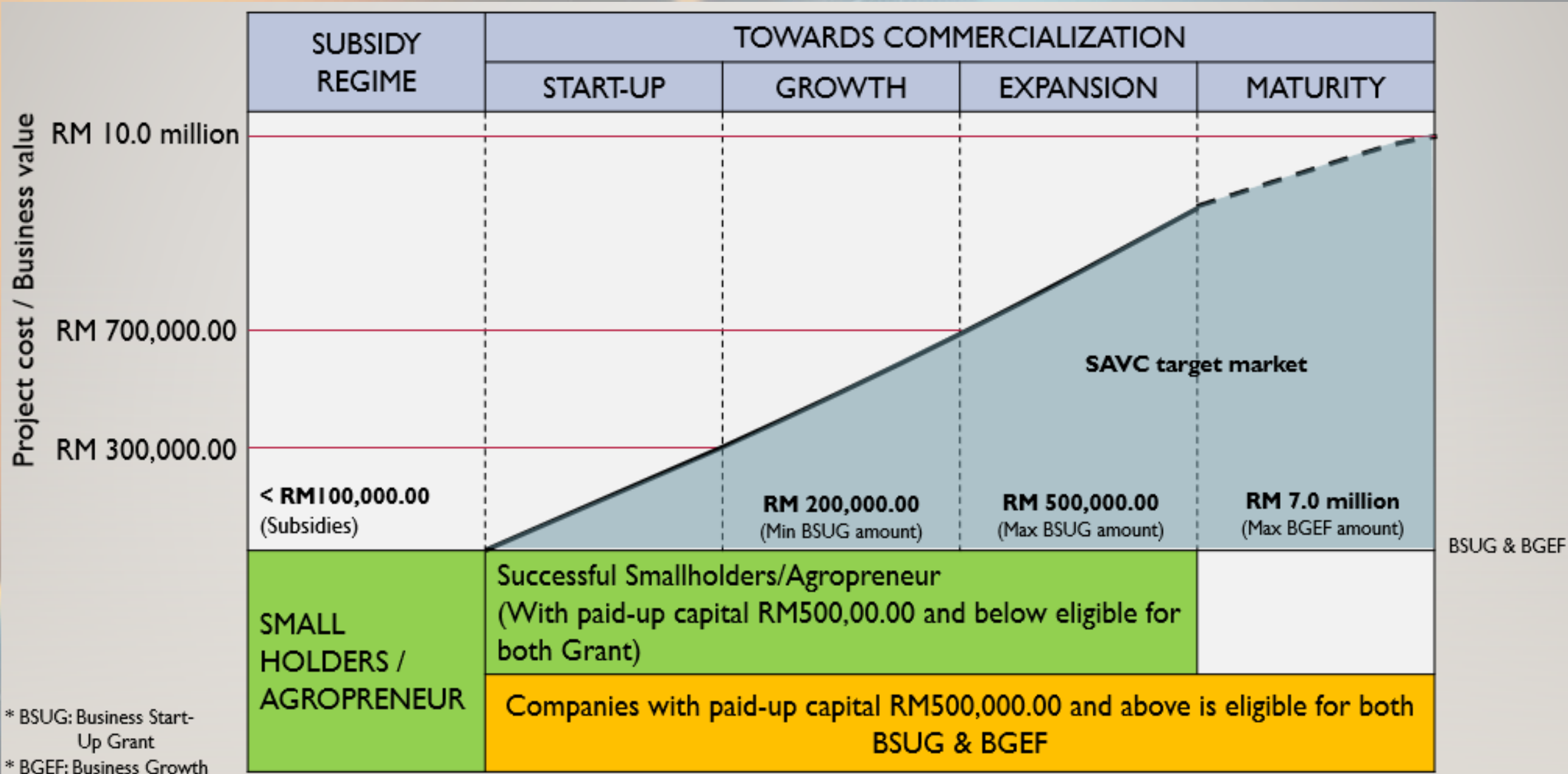
## *Eligible Applicant*

Private limited company

## *Criteria*

1. Has been in operation for at least for 3 years;
2. Paid up capital at least RM500,000.00;
3. Improving turnover, profitability & net worth;
4. Clear business & marketing plan for next higher level;
5. Must have technical experience, key technical person & technical support related to the project;
6. Had firmed buyers;
7. Buyers interest as indicated by Letter of Intents, purchase Agreement, Buy Back Contract etc.

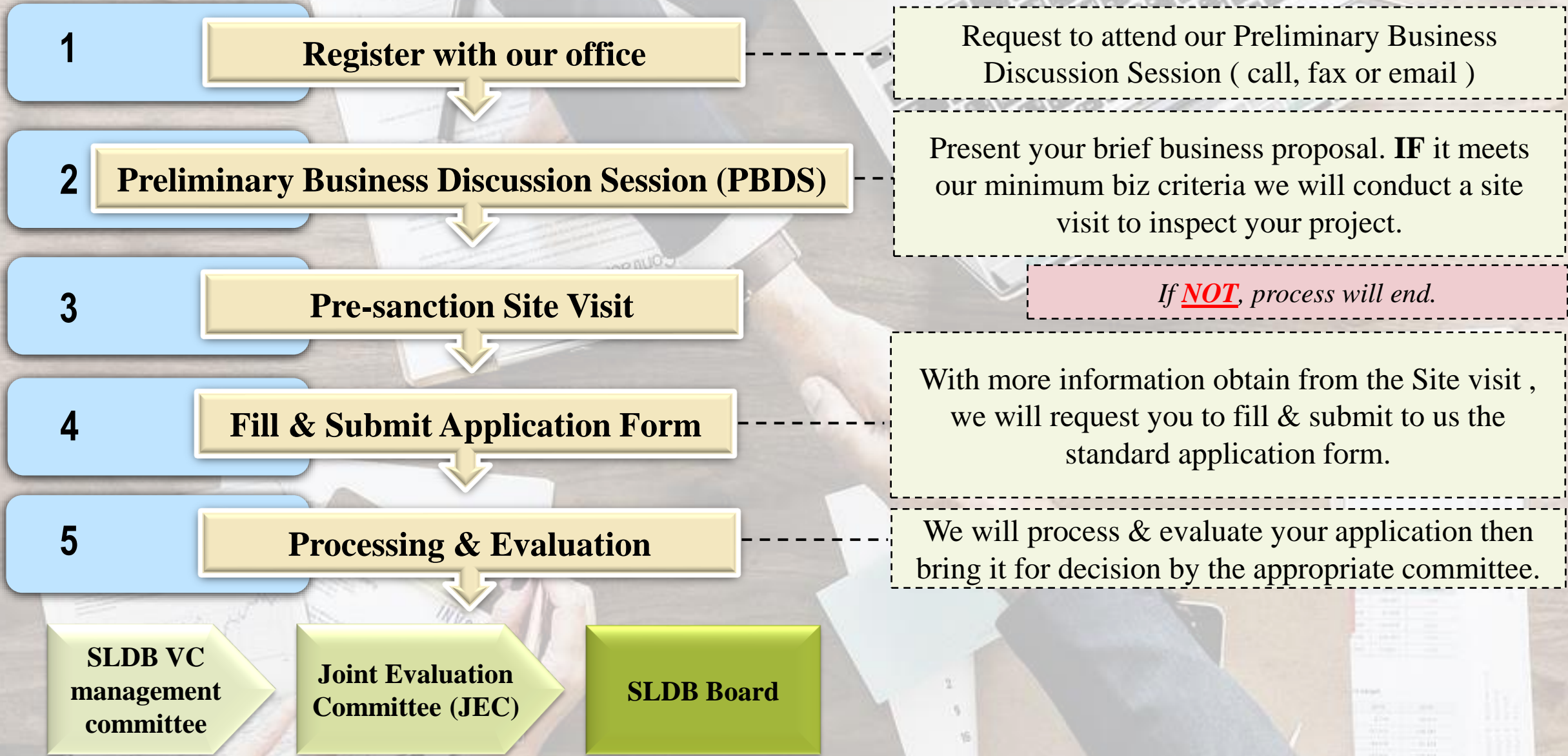
